
Appendix 13 Emails from Joey Gilbert - he never thought these emails would be made public.




Actually, David. Just thinking, is there any way we can add Joey on even though briefs have been field?

21	4. The Court finds that Mr. Gilbert's Contest is a frivolous action that warrants sanctions
22	under NRS 18.010(2)(b) and NRS 7.085(1). Mr. Gilbert did not-and could not-present any
23	admissible evidence to support the case-dependent thesis that the restored election results show he
24	received the most votes in the 2022 Primary. The fundamental lack of evidence on this pivotal issue
25	proved fatal to the Contest as the Court granted summary judgment in Mr. Lombardo's favor at the
26	conclusion of discovery. See Order dated August 11, 2022 (on file). Because "[a]n action is not
27	well-grounded when there is no evidence to support it," Watson Rounds, P.C. v. Eighth Judicial
